### 1. Product and compagny identification:

### 2. Hazards identification

**Physical State:** All compounds in FloraMato™ are in aqueous solution.

**Color:** Pink

**Solubility:** FloraMato™ is readily soluble in water

**Hazard statements:** OXIDIZER. CAUSES EYE AND SKIN IRRITATION. MAY BE HARMFUL IF SWALLOWED. MAY CAUSE RESPIRATORY TRACT IRRITATION. CONTAINS MATERIAL THAT MAY CAUSE TARGET ORGAN DAMAGE, BASED ON ANIMAL DATA. SUSPECT CANCER HAZARD - CONTAINS MATERIAL WHICH MAY CAUSE CANCER.

**Precautionary measures:** Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Do not eat, drink or smoke when using this product. Avoid contact with eyes, skin and clothing. Keep away from clothing and other combustible materials. Store in tightly-closed container. Keep container tightly closed. Use personal protective equipment as required. Wash thoroughly after handling.

**Routes of entry:** Dermal contact. Eye contact. Inhalation. Ingestion

#### Potential acute health effects

**Inhalation:** Moderately irritating to the respiratory system. Exposure to decomposition products may cause a health hazard. Serious effects may be delayed following exposure.

**Ingestion:** Harmful if swallowed.

**Skin:** Irritating to skin.

**Eyes:** Irritating to eyes.

#### Potential chronic health effects

**Chronic effects:** Contains material that may cause target organ damage, based on animal data.

**Carcinogenicity:** Contains material which may cause cancer. Risk of cancer depends on duration and level of exposure

**Mutagenicity:** No known significant effects or critical hazards

**Teratogenicity:** No known significant effects or critical hazards

**Developmental effects:** No known significant effects or critical hazards

**Target organs:** Contains material which may cause damage to the following organs: upper respiratory tract.

#### **Medical condition**

**aggravated by overexposure** Pre-existing disorders involving any target organs mentioned in this MSDS as being at risk may be aggravated by over-exposure to this product.

### **3. Composition/information on ingredients**

**Ingredients :** FloraMato™ is an especially formulated mixture of chemicals that are mixed in proportions to assure excellent plant nutrition. The chemical identity of the compounds and exact proportions used in the mixture are a trade secret, however, they are derived from : Potassium Nitrate, Magnesium Nitrate, Ammonium Nitrate, Potassium Phosphate, Magnesium Phosphate, Potassium Carbonate, Potassium Sulfate, Magnesium Carbonate and Magnesium Sulfate.

**Exposure limits:** As long as these chemicals remain in aqueous solution they do not present an inhalation hazard.

### **4. First aid measures**

**Eye contact:** Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 20 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.

**Skin contact:** In case of contact, immediately flush skin with plenty of water for at least 20 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Clean shoes thoroughly before reuse. Get medical attention immediately.

**Inhalation:** Move exposed person to fresh air. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Loosen tight clothing such as a collar, tie, belt or waistband. Get medical attention immediately.

**Ingestion:** Wash out mouth with water. Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical attention immediately.

Protection of first-aiders: No action shall be taken involving any personal risk or without suitable training. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Wash contaminated clothing thoroughly with water before removing it, or wear gloves.

**Notes to physician:** In case of inhalation of decomposition products in a fire, symptoms may be delayed. The exposed person may need to be kept under medical surveillance for 48 hours.

### **5. Fire-fighting measures**

FloraMato™ is not combustible. However, some components are powerful oxidizers and can initiate and intensify combustion of flammable materials.

**Extinguishing Agents:** Flood fires involving FloraMato™ with water. Keep fire exposed containers cool with water spray. Remove containers from the fire area, if it can be done safely.

**Unusual Fire/Explosion Hazards:** FloraMato™ contains chemicals that are strong oxidizing agents which support combustion and can be an explosive hazard if heated under confinement that allows high pressure build up.

**Special fire Fighting Procedures:** Toxic fumes/gases can be evolved in a fire situation. Fire fighters should use self-contained breathing apparatus (SCBA). Wear full protective gear, and avoid skin and eye exposure to splashes or mists of solutions formed by use of water as a fire control measure. Be aware of runoff from fire control methods. Do not release to sewers or waterways.

### **6. Accidental release measures**

**Personal precautions:** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see Section 8).

**Environmental precautions:** Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

#### **Methods for cleaning up**

**Small spill :** Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Do not absorb in sawdust or other combustible material. It may lead to a fire risk when it dries out. Use spark-proof tools and explosion-proof equipment. Dispose via a licensed waste disposal contractor.

**Large spill :** Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Do not absorb in sawdust or other combustible material. It may lead to a fire risk when it dries out.

Use spark-proof tools and explosion-proof equipment. Dispose via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. Note: see Section 1 for emergency contact information and Section 13 for waste disposal.

## **7. Handling and storage**

**Handling :** Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

**Storage :** Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.

## **8. Exposure controls/personal protection**

**Recommended monitoring procedures:** If this product contains ingredients with exposure limits, personal, workplace atmosphere or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.

**Engineering measures:** Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.

**Hygiene measures:** Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. Ensure that eyewash stations and safety showers are close to the workstation location.

### **Personal protection**

**Respiratory:** Use a properly fitted, air-purifying or supplied air respirator complying with an approved standard if a risk assessment indicates this is necessary. Respirator selection must be based on known or anticipated exposure levels, the hazards of the product and the safe working limits of the selected respirator.

**Hands:** Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary. Considering the parameters specified by the glove manufacturer, check during use that the gloves are still retaining their protective properties. It should be noted that the time to breakthrough for any glove material may be different for different glove manufacturers. In the case of mixtures, consisting of several substances, the protection time of the gloves cannot be accurately estimated.

**Eyes:** Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists or dusts. If contact is possible, the following protection should be worn, unless the assessment indicates a higher degree of protection: chemical splash goggles.

**Skin:** Personal protective equipment for the body should be selected based on the task being performed and the risks involved and should be approved by a specialist before handling this product.

**Environmental exposure controls:** Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.
